Key Addresses:

Sri Kishore Kumar Poludasu, DMD (HR) & CDO,



paid tribute to Com. L.V. Subramaniam for his pioneering role in shaping the officers' trade union movement and improving service conditions. He emphasized the importance of protecting the Bank's market share amid challenges thrown by fintech companies, maintaining ROA, upholding the institution's values, and ensuring work-life balance while placing Human Resources at the centre stage.

Com. CH Venkatachalam, GS AIBEA, lauded AISBOF's stature as the largest supervisory union in Indian banking. He discussed pressing issues such as the five-days work week and pension updation, expressing confidence that these would soon be resolved under UFBU's determined leadership while advocating for a protracted unity and solidarity amongst the constituents of UFBU.

Com. L. Chandrasekhar, GS AISBISF & NCBE, extended fraternal greetings and highlighted concerns such as promotion hesitancy due to flawed appraisal systems and critical staff shortages. He praised the Federation's advocacy on common issues and emphasized on solidarity within UFBU.

Com. R. Sekaran, President AIBOC, recounted AISBOF's historic 17-day managerial cadre strike, the first of its kind globally as a watershed moment for officers' trade unionism. He cautioned against privatization, outsourcing, and erosion of bipartisanship, while urging members to stay connected with the grassroots.

In a heart-warming gesture, the Federation

honoured Shri Dhanvanthari, staff member of the Hyderabad Circle Association Guest House, for his extraordinary efforts in educating his two children to become successful doctors. The renowned weaver of Hyderabad Shri Nalla Vijay Kumar who threads magic in his art of shawl making was also felicitated to encourage handicraft and artisan prowess of an individual.

In his Presidential Address, Com. Arun Kumar Bishoyi, the President, expressed his gratitude



for all the participants as well as the guests and lauded the efforts made by the comrades of Hyderabad Circle under the leadership of Com. Hatkar Shankar and Com Anjaneya Prasad for making the inaugural session a grand Success. He deliberated upon the milestones achieved during the period under report and also highlighted on the challenges ahead.

The meeting drawn its culmination with vote of thanks, proposed by the General Secretary of the SBIOA Hyderabad Circle thanking all the participants, dignitaries. Leaders and expressed his gratitude for making the event a grand success.

Business Sessions - 28th & 29th June

Com. Arun Kumar Bishoyi presided over the Business Sessions, called the meeting to order, read the notice of the meeting and called upon the General Secretary to present the Secretarial Report before the house along with the annexed accounts. The undersigned delivered a comprehensive report, covering developments at international, national, and organizational levels. He highlighted the Federation's



achievements over the past three years, particularly in resisting governmental pressures, and applauded the members' steadfast support during the period under report and all along.

Special Address in the midst of Delegate session - 28th June 2025 by Sri Vinay M. Tonse, Managing Director (RB&0)

It had been a pulsating moment when the Managing Director (RB&O) Sri Vinay M. Tonse,



entered the venue on 28th of June 2025, amidst thundering slogans to address the houseful of delegates, observers and guests. The dignitary who could not attend the inaugural session due to his prior commitments, made a special appearance during the Delegate session proceedings and delivered a profoundly inspirational address that resonated with the delegates.

He expressed deep concern over a growing sense of inner dissatisfaction among officers, despite their commendable performance, and called for a period of honest introspection and self-awareness. Emphasizing the enduring legacy of our esteemed

institution, he reaffirmed confidence in the PPPT framework—People, Processes, Products, and Technology—highlighting especially the merit-based, committed, and capable human capital that has always been the bedrock of SBI.

He expounded upon the gradual weakening of the emotional bond with the institution among newer generations of officers and urged the leadership of the Federation and its affiliates to rise to the occasion by nurturing a culture of empathetic mentorship and emotionally intelligent leadership. He opined that assertiveness must never translate into harshness, and preserving the dignity and self-respect of every officer should remain paramount. He calls upon the leaders to remain attentive to signs of emotional distress, and providing timely encouragement and support treating them just like family members.

Sharing his personal life philosophy, "MAD – Make A Difference" he encouraged officers to pursue holistic growth in personal, professional and emotional wellbeing. Wellness, reading, and daily self-reflection should become routine disciplines. He asserted that 10–15 minutes of reading each day can have a transformative impact.

He spoke movingly on the dual roles each of us plays at home and at workplace. Leaders, he stressed, must contribute positively to both. A small gesture, a positive word, or a thoughtful response can leave a lasting impact on the emotional quotient of colleagues and family alike. Each individual must be seen as an asset and not a challenge. Deficiencies must be addressed through mentorship rather than criticism, building a workplace anchored in trust, empathy, and mutual aids.

Concluding his address on a deeply motivational note, he reminded that growth is always possible in empathy, leadership, systems and in self-discipline. As officers, as leaders, and as an institution, we must continuously strive to remain relevant in a changing world.

His parting words, simple yet profound,

encapsulated the spirit of his message:

"Keep Dreaming, Keep Smiling."



He was felicitated by Com. Arun Kumar Bishoyi and the undersigned on behalf of the Federation.

Delegate Deliberations

Forty-six delegates from across the country spoke on key issues featured in the General Secretary's Report. While many praised the Federation's functioning and termed the Report a "document worth preserving," they also raised critical concerns on the following issues:

- * Work-life balance / Working on Holidays and Sundays.
- * Toxic work culture.
- * Staff shortages / Recruitments.
- Conversion of specialists into generalists Cadre.
- * Linking of reimbursements to Mandatory learnings/RBC.
- * Wage disparities and stagnation increments
- * Withheld of increments on opting-out of promotion.
- * Meaningful MPP exercise and implementation.

- * Immunity for Regional Secretaries
- * Revisit the concept of existing DA hubs and dispensable of equitable justice.
- * Compassionate Appointment: Eligibility criteria
- ***** E-AB's: One time Option to revert back to SBI Pension
- * Accommodative Transfer Policy for women officers
- * Revisiting the criteria for classification of difficult/most difficult centres.
- * Reverting back to OPS from NPS.
- * Shortcomings/issues in the Uniform Transfer Policy.
- # Issues relating to Cross-selling / Mis-selling.
- * Anomalies related to CDS and discrepancies in CDS linked PLI.

The General Secretary responded comprehensively, addressed all concerns and reiterated the Federation's resolve to fight for a **five-days work week**, cautioning that a decisive agitation may be necessary if justified demands remain unaddressed.

Adoption of Reports and Resolutions

- The Minutes of 28th Triennial General Council meeting, General Secretary's Report and Accounts were unanimously adopted.
- → Com. Shubhajyoti Chattopadhyay presented proposed amendments to the By-Laws, and Com. Bhushan Mahajan tabled Resolutions addressing critical concerns of officers and unions.
- ♦ Both the amendments and resolutions were unanimously approved by the House.

The appointment of M/s Jayachandran & Co. as Chartered Accountants for 2025–2028 was also ratified.

Elections and New Team Formation

The house approved the appointment of Com. Prabir Sorkhel as Returning Officer and Com. Sanjib Sen as Assistant Returning Officer. The election process conducted for the new Executive Committee in a professional, fair and transparent manner. Com Arun Kumar Bishoyi and the undersigned were unanimously elected as President and General Secretary of AISBOF for the triennial period 2025-2028 respectively. The newly elected President and General Secretary along with their new team was invited to the dais with warm applause and the President and General



Secretary of the host circle felicitated them with applause rumbling all across.

Newly elected President Com. Arun Kumar Bishoyi and the undersigned, as General Secretary, addressed the house, expressing profound gratitude for the trust reposed in them. They vowed to uphold the dignity and self-respect of Officers at all costs and lead with wisdom drawn from the Council's deliberations.

AIBOC CONTINUES TO EXTEND ITS SOLIDARITY AND UNWAVERING SUPPORT TO THE GENERAL STRIKE ON 09.07.2025 CALLED BY CENTRAL TRADE UNIONS AND INDEPENDENT SECTORAL FEDERATIONS OF WORKERS

Text of AIBOC Circular No. 2025/29, dated 05.07.2025.

All-India Bank Officers' Confederation (AIBOC), the largest trade union organisation in Banking Sector enjoying affiliation of over 325000 active members extends its whole hearted support and solidarity for the General Strike scheduled on the 20th day of May, 2025. This strike call given by the joint platform of Central Trade Unions and various independent sectoral federations of workers and employees as we wish shall encrypt a new chapter in the history of trade union movement and shall be pivotal in establishing trade union rights. Several national-level federations and associations in the banking and financial sectors shall also join the proposed general strike to give it a thunderous success.

The working class in India has been experiencing a colossal decline in purchasing power owing to the unequal distribution of wealth and decline of actual income while the price escalation has been rampant and uncontrolled. The unrestrained concentration of wealth to some selected few is widening the gap between haves and have nots and resulting in erosion of small and medium enterprises, causing deindustrialization of significant segments of the economy which in turn has contributed immensely towards rising of unemployment. History is a testament to the fact that when, economic distress worsens, the state is destined to resort to more coercive measures bringing in havoc in the life and liberty of the working class.

The government has introduced four Labour Codes that subsume the existing 29, aiming to impose more restrictions that exploit workers and favour corporate houses. These Labour Codes are not merely regulatory tools; but form a system designed to instil fear among the working class.

As an arm-twisting tactic as evident in recent time, the Section 111 of the BNS, i.e. the amended Indian Penal Code has been seen misused by one of the Govt. authority, branding the organized trade union activity as an organized crime, and categorized it as a non-bail able offence. On the other hand, the Corporates have been given an open discount to close or shut down their business/ firms and layoff their workers diluting the legal obligations and statutory compulsions associated with exercise of such measures. The entire state machinery is being restructured to launch a direct attack on the rights and privileges of workers. These codes are intended to pave the way for further privatization, including in the banking and financial sectors and AIBOC vouch to halt any such heinous attempt on the part of the protagonists.

Existing labour laws are the result of over a century of struggle and sacrifice by the working class. We cannot allow the repeal of these laws without resistance. This move aligns with the neo-liberal economic policies being followed by the government and can only be countered by building a unified working-class struggle. The working class must not remain passive victims; rather, we should actively shape the future of the Indian economy. AIBOC stands at the forefront of this struggle and will not shy away from the battle between capital and labour. We will continue to advocate for an alternative economic vision where people and the public sector play a decisive role.

We call upon all our affiliates and state units to participate in protest demonstrations, seminars, or meetings organized by the sponsors of the strike, especially the associations of financial institutions to express our solidarity and support for its cause. Additionally, our members will not act as strike-breakers nor take on any non-supervisory duties on the day of the strike.■

CELEBRATING THE 56TH ANNIVERSARY OF BANK NATIONALISATION DAY

Text of AIBOC Circular No. 2025/30, dated 08.07.2025.

It is time to reflect once again, on the momentous day of July the 19th and sense pride of an event that changed the course of Banking in the economic landscape of the country. The nationalisation of major banks in 1969 is not just a calendar event but it represents a fundamental shift towards a more equitable and inclusive financial system, a vision that our trade union has consistently campaigned and advocated for.

The event of nationalisation was an unswerving response to the needs of our budding independent nation. Prior to 1969, banking was largely concentrated in private hands, primarily serving the interests of big business houses and mostly concentrated in urban centres. Rural India, agriculture, small-scale industries, and the common person were largely excluded from the formal financial system. The consequences were visible through economic disparity, limited access to credit for productive purposes, and resultantly the banking sector failed to truly serve the nation's developmental aspirations keeping in pace with the needs.

Nationalisation marshalled a new era when the Public sector banks became instruments of socio-economic changes, facilitating banking services to the remotest corners of the country, financing agriculture through schemes like priority sector lending, promoting small and medium enterprises, and empowering millions through financial inclusion initiatives. It was the Public Sector Banks that played a crucial role in the Green Revolution, in poverty alleviation programs, and in making banking accessible to the common man, nurturing a culture of savings and investment amongst the citizenry.

As a proud activist of the banking sector trade union movement, we take immense pride in the role we have played in restoration and sustenance of the public sector fabric of our banks. Our collective efforts, our struggles, and our unflinching commitment have ensured that public sector banking remains relevant and gregarious in India's economy. We have fought against policies intended to dilute the public character of our banks and have consistently advocated for their robust growth and expansion with a bird's eye view of embracing rural economy and agrarian development.

However, we are not oblivious to the challenges ahead that demands for a more consolidated efforts in coming days to counter and propagate. In recent years, we have witnessed persistent attempts to compromise with the progress and autonomy of PSBs through various means.

The incalcitrant motive around privatisation poses a significant threat to the very essence of public sector banking. We firmly believe that privatising PSBs would not only stall the financial inclusion initiatives but also concentrate wealth and power in a few hands, degenerating the gains made over decades and revert the position back to what had prompted the then dispensation to embrace the idea of bank nationalisation.

Continuous understaffing, coupled with increasing workload and pressure to meet illogical targets poses immense strain on our colleagues. We demand adequate recruitment and a congenial work environment in our bid to ensure survival and sustenance of the Public Sector Banks and defeat the ploy to frustrate the workforce and thus deliberately cause injury to the prospect of the Public Sector Banks.

There have been instances where employees'

rights have been infringed, where employees have been subjected to mental and physical assaults. There have been instances when the autonomy of our bank boards has been invaded. All these to encroach upon the prosperity of our banks, notwithstanding the consistent and unbeatable performances that the nationalised banks are displaying years after years sustaining against all the odds. Such cultivated and ill-conceived motive can be construed as a direct attack on the prospect and prosperity of the Public Sector Banks.

On this Bank Nationalisation Day, let us reaffirm our commitment to defend Public Sector Banking. We must continue to be vigilant against any attempts to privatise or dilute the public sector character of our banks.

We will continue to fight for fair treatment, secured working conditions, adequate recruitment, autonomous functioning, a supportive policy environment affording a level playing field for PSBs to thrive and dignified work environment for all bank employees.

We will advocate for policies that further excavate financial inclusion and ensure that

JUDGMENT

H.S. BEDI, J.- The workman-appellant was appointed as a Technician Grade-II in the PGI on 7.5.1981 on ad hoc basis initially for a period of six months. His services were terminated w.e.f. 30.4.1984 vide order dated 27.4.1984 as per terms and conditions of the letter of appointment. He challenged this order before the Labour Court. The Labour Court found that the petitioner's service had been terminated without complying with the provisions of section 25-F of the Industrial Disputes Act, but declined reinstatement to the appellant and instead granted a compensation of ₹ 4,000/- in lieu thereof. The award of the Labour Court was challenged by the workman-appellant by way of Civil Writ Petition No. 3723 of 1986, which too has been dis-missed on 21.5.1993 by the learned Single Judge holding that as the petitioner had been appointed for a specific period and the said period had expired even assuming for the sake of argument that there had been a violation of the provisions of section 25-F of the Industrial Dispute Act, compensation alone was the proper relief under

the circumstances. The present appeal has been filed against the judgment of the learned Single Judge.

We have heard Mr. Dinesh Kumar, the learned Counsel for the appellant and have gone through the record.

2. We too are of the opinion that the workman appellant would have been gainfully employed after his services had been terminated in 1984. As he has statedly attained the age of superannuation, the question of reinstatement does not arise. We are, however, of the opinion that the amount of $\stackrel{?}{\sim} 4,000$ / - awarded by the Labour Court as compensation is clearly inadequate and some increase is called for. We accordingly increase the amount of compensation from $\stackrel{?}{\sim} 4,000$ /- to $\stackrel{?}{\sim} 20,000$ /-

With this modification, the appeal is dismissed.

Appeal Dismissed.
